### **Liquidators' First Report**

### 1 INTRODUCTION AND APPOINTMENT

Old Auckland Grocers Market Limited ("the company") was placed into liquidation by the High Court at Auckland pursuant to Section 241(2)(c) of the Companies Act 1993 ("the Act") on 22 February 2018 upon the application of Tegel Foods Limited. Peri Micaela Finnigan and lain McLennan, CAANZ Accredited Insolvency Practitioners, of Auckland, were appointed as joint and several liquidators of the company.

On 19 February 2018 John Michael Gilbert of C & C Strategic Limited was appointed as Receiver and Manager of the company.

Old Auckland Grocers Market Limited (In Receivership & In Liquidation) (formerly known as Grocer's Market Limited until 18 January 2018) owned the physical assets for the Grocers Market Store in Mt Eden, Auckland.

Old Auckland Grocers Market Limited purchased the assets from Mt Eden Food Co Limited (In Receivership) in 2017. Mt Eden Food Co Limited was part of the Nosh group of companies.

Old Auckland Grocers Market Limited was placed into liquidation on 22 February 2018 on the application of Tegal Foods Limited. The Receiver was appointed by 19 February 2018 by Mt Eden Food Co Limited (In Receivership).

The assets of the company are in the hands of the receiver. From our discussions with the receiver the business of the company has not been traded on following his appointment.

### **5 STATEMENT OF AFFAIRS**

The assets of the company are in the hands of the receiver.

### 6 ASSETS AND PROPOSALS FOR CONDUCTING THE LIQUIDATION

We will realise all available assets.

We will complete a thorough review of the company's books, records and affairs to:

- ensure that all assets have been properly accounted for,
- determine if there are any other avenues of recovery for creditors,
- determine if the company's officers have properly carried out their duties and take appropriate steps where necessary.



If there are funds available for distribution to creditors we will verify creditors' claims and make a distribution. We will then complete the liquidation and request that the Registrar of Companies remove the company from the register.

### 7 LIABILITIES AND CREDITOR CLAIMS

### 7.1 Secured Creditors

As at the date of liquidation four secured parties had registered security interests against the company on the Personal Property Securities Register. The liquidators have not yet reviewed the validity of their securities

### 7.2 Preferential Creditors

We have requested a creditor's claim form from the applicant creditor.

The Inland Revenue Department has not yet provided us with a creditor's claim form but we understand that there are amounts due in respect of GST, PAYE and other payroll deductions.

### 7.3 Unsecured Creditors

The quantum of the unsecured creditors' claims in the liquidation is unknown at this time. A schedule of known creditors and their addresses is provided at Appendix 1, as required by Section 255(2)(c) of the Act.



A notice to creditors to prove debts or claims is included at Appendix 3. Also enclosed is a creditor's claim form for completion and return to this office by Monday, 30 April 2018. Creditors that have not made a claim by the date on the notice may be excluded from any distribution made. If you believe that you are a secured creditor please contact us and the appropriate form will be sent to you.

### 8 CREDITORS' MEETING / LIQUIDATION COMMITTEE

A notice of the Liquidators' decision to dispense with the meeting of creditors is provided at Appendix 2.

Pursuant to Section 314 of the Companies Act 1993, creditors are advised that at any time in the course of the liquidation the Liquidator shall, at the request in writing of any creditor or shareholder, call a meeting for the purpose of appointing a liquidation committee.

### 9 FURTHER INFORMATION
