EVENTS LEADING TO APPOINTMENT OF LIQUIDATORS 3.

Rowan John Chapman and Amanda-Jane Atkins of WHK Gosling Chapman were appointed joint and several receivers and managers of the property of the above company on 17 April 2009. All assets are currently under the control of the receiver.

4. STATEMENT OF AFFAIRS

All assets are currently under the control of the receivers however, they have quoted "it would appear that there will be insufficient funds from the realisation of assets and current work in progress to satisfy the claims of the secured creditors and therefore, the likelihood of any distribution to unsecured creditors is very low." We hereby attach a statement of affairs completed by the receivers.

After having regard to the assets and liabilities of the company and the likely result of the liquidation, it is proposed to dispense with a meeting of creditors pursuant to Section 245 of the Companies Act 1993.

You are advised that should you desire a meeting, notice in writing is required within 10 working days of receiving this notice.

Note: Pursuant to Section 314 of the Companies Act 1993 creditors are advised that at any time in the course of the liquidation the Liquidator shall, at the request in writing of any creditor or shareholder call a meeting for the purpose of appointing a Liquidation Committee.
