lain McLennan and Boris van Delden, Insolvency Practitioners of Auckland, were appointed jointly and severally as liquidators of Brusan Designs Limited ("the company") on 10 December 2007.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. At the time of this report, we have been advised that Mr John Henry Ede has been found guilty of 23 charges under the Insolvency Act, Crimes Act, and Companies Act, and has been sentenced to over 3 years in prison. We will now move on to consider recovery actions. We provide positive solutions for businesses
