#### 1 INTRODUCTION AND APPOINTMENT

Boris van Delden and Peri Micaela Finnigan, Insolvency Practitioners of Auckland, were appointed jointly and severally as liquidators of Gibson Rusden Design Auckland Limited ("the company") on 7 August 2014.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. This eighth report should be read in conjunction with the liquidators' previous reports. This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.

A Statement of Realisations and Distributions is attached.

#### 3 CONDUCT OF THE LIQUIDATION DURING THE PRECEDING SIX MONTHS

#### **Asset Realisations**

#### 3.1 Reparations Order

A past employee of the company has had a reparations order made against them for \$78,842. Payments are being made on a weekly basis of \$125.00. Total recoveries to date are \$20,637. There have been cessations in payment over the last 6 months. Ministry of Justice continues to monitor the matter.

#### 4 INVESTIGATIONS

The liquidators have completed their investigations into the books, records and affairs of the company.





#### 5 CREDITORS' CLAIMS

#### 5.1 Preferential Creditor

The Inland Revenue Department has submitted a preferential claim for \$65,792. To date the Inland Revenue Department have received \$7,087 for PAYE arrears, and a distribution totalling \$26,751 towards their preferential claim of \$65,792 in the liquidation.

#### 5.2 Unsecured Creditors

As at the date of preparing this report six unsecured creditors claim forms have been received which total \$33,524. In the interests of minimising liquidators' fees, the liquidators will not attend to the formality of accepting or rejecting creditors' claims unless we are in a position to pay a distribution.

#### **6 FUNDS / LIKELY OUTCOME**

It is uncertain at this time whether or not there will be a distribution to unsecured creditors.

#### 7 MATTERS DELAYING THE COMPLETION OF THE LIQUIDATION

The following matter is outstanding:

Monitor collection of reparations payments.

#### 8 ESTIMATED DATE OF COMPLETION

Based on the information contained in this report the liquidators presently propose to complete all outstanding matters with a view to retiring as liquidators within the next 10 years.
