Liquidators' Second Report For the period from 03 July 2020 to 02 January 2021

1 INTRODUCTION AND APPOINTMENT

Boris van Delden and Iain McLennan, Licensed Insolvency Practitioners, of Auckland, were appointed as joint and several liquidators of Greentech Investments Limited (in Liquidation) ("the company") on 03 July 2020.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. This second report should be read in conjunction with the liquidators' previous report(s). This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.

A Statement of Realisations and Distributions is **not** attached as there have not been any receipts or payments in the liquidation.

2 RESTRICTIONS

3 CONDUCT OF THE LIQUIDATION DURING THE PRECEDING SIX MONTHS

To date the director has provided some cooperation in the liquidation process

Asset Realisations

3.1 Bank Accounts

(Statement of Affairs: \$Nil)

The company had no bank accounts open at the date of liquidation.

3.2 *Other assets*

The company had not actively traded for many years prior to liquidation however it was being utilised to provide a base for a new enterprise that had not commenced as at the date of liquidation. No physical assets have been identified. Steps have commenced to recover intangible assets and chose in action.

4 INVESTIGATIONS

The liquidators' investigations into the books, records and affairs of the company is ongoing.

5 CREDITORS' CLAIMS

5.1 *Secured Creditors*

No secured creditors claims have been received to date.

5.2 *Preferential Creditors*

A preferential claim has been received in respect of the applicant creditor's costs and disbursements of \$4,213.

No dividend has been paid to preferential creditors at the date of this report.

5.3 *Unsecured Creditors*

As at the date of preparing this report 1 unsecured creditor claim form has been received claiming \$109,015. This claim has been admitted in the liquidation.

6 LIQUIDATORS' FEES

Liquidators' fees to the date of this report are \$5,520 excluding GST. The fees are based on 19.5 hours of work undertaken as follows:

Liquidators' fees in a Court ordered liquidation are to be approved by the Court and if required a retrospective application for fee approval will be made by the liquidators.

Section 284 (1) of the Act provides that an application (with the leave of the Court) may be made by a creditor, shareholder or director of a company in liquidation to review or fix the remuneration of the liquidators.

7 FUNDS / LIKELY OUTCOME

It is too early to determine whether or not the liquidation will proceed and whether there will be a distribution to unsecured creditors.

The following matters are outstanding:

It is currently too early to estimate a date of completion for the Liquidation.
