Boris van Delden and Iain McLennan, Licensed Insolvency Practitioners, of Auckland, were appointed as joint and several liquidators of Greentech Investments Limited (in Liquidation) ("the company") on 03 July 2020.

#### 3.1 **Bank Accounts**

The company had no bank accounts open at the date of liquidation.





# 3.2 Other assets

The company had not actively traded for many years prior to liquidation however it was being utilised to provide a base for a new enterprise that had not commenced as at the date of liquidation. No physical assets have been identified. The company director has provided information to the liquidators claiming there is a dispute. The liquidators have reviewed that information and have concluded that the claim that there is a dispute is not consistent with the information provided by the director.

Steps are being taken to recover intangible assets and a chose in action.

The liquidators' investigations into the books, records and affairs of the company is complete.

#### 5 CREDITORS' CLAIMS

#### 5.1 Secured Creditors

No secured creditors claims have been received to date.

# 5.2 Preferential Creditors

A preferential claim has been received in respect of the applicant creditor's costs and disbursements of \$4,213.

No dividend has been paid to preferential creditors at the date of this report.

#### 5.3 Unsecured Creditors

The claim from 1 unsecured creditor owed \$109,015 has been admitted.

# 6 LIQUIDATORS' FEES

Liquidators' fees to the date of this report are \$5,520 excluding GST. The fees are based on 19.5 hours of work undertaken as follows:
