1. INTRODUCTION

John Trevor Whittfield and Peri Micaela Finnigan, Insolvency Practitioners, of Auckland, were appointed jointly and severally as receivers and managers of all security interest in all present and after acquired personal property and all assets and undertakings, both present and future, of the company on 12 October 2007. Pursuant to section 24 of the Receiverships Act 1993, the receivers report herewith on the progress of the receivership. This second report should be read in conjunction with the receivers first reports. A statement of realisations and distributions is attached.

2. PROPERTY DISPOSED OF TO DATE

The boat Kahawai has been sold for \$9,000 (including GST).

3. PROPOSALS FOR DISPOSAL OF RECEIVERSHIP PROPERTY

The receivers have identified significant assets of the company, being 10 Wessex helicopters and associated parts. These assets are located in both the UK and New Zealand. Those helicopters and parts have been sold by international tender with settlement pending. A deposit has been received for the U.K. and New Zealand helicopters sold.

Because of the commercial sensitivity of the negotiations with all parties, the receivers cannot comment further on this matter.

4. AMOUNTS OWING TO SECURED CREDITOR

The amount of \$3,015,451 (including accrued interest) was due to our appointer at 30 September 2007. Penalty interest has been accruing since that date.

Significant loans are also owed to another secured lender.

5. PREFERENTIAL CREDITORS

We have yet to receive any formal claims from the company's preferential creditors.

UNSECURED CREDITORS 6.

There will be no moneys available for unsecured creditors.



7. LEGAL PROCEEDINGS

The receivers have had to engage in substantial legal proceedings to secure assets and obtain company information. At the date of this report the receivers and secured lenders were in negotiation to settle all matters. We can now report that a Settlement Deed has been signed.
