Liquidators' First Report

1 INTRODUCTION AND APPOINTMENT

Installers Group Limited ("the company") was placed into liquidation by a special resolution of the shareholders pursuant to Section 241(2)(a) of the Companies Act 1993 ("the Act") on 11 November 2013. Peri Micaela Finnigan and Boris van Delden, Insolvency Practitioners of Auckland, were appointed as joint and several liquidators of the company.

2 RESTRICTIONS

This report has been prepared in accordance with Section 255(2)(c) of the Act. In preparing this report and its appendices we have relied upon information provided to us. We have not independently verified or audited that information. Whilst all care and attention has been taken in compiling this report, we do not accept any liability whatsoever to any party as a result of the circulation, publication, reproduction or use of this report.

We reserve the right (but are under no obligation) to review and, if we consider necessary, revise this report in respect of any information existing at the date of this report which becomes known to us after that date.

The company entered into a company compromise with creditors. The compromise payments were not able to be maintained on the compromise debt along with current trading obligations. The Inland Revenue Department served a statutory demand and following this, the company made the decision to place the company into liquidation. The insulation industry has suffered significant setbacks with the withdrawal of Government funding which has led to many companies in the industry failing. The industry is also typically slower in the summer months. The business has been valued by an independent registered valuer and the liquidators intend to sell the business assets at market value to a new owner. The director is likely to be involved in the new business and will send a successor company notice to all his suppliers.

5 STATEMENT OF AFFAIRS

A Statement of Affairs showing the company's estimated financial position as at the date of our appointment is provided at Appendix 1.

6 ASSETS AND PROPOSALS FOR CONDUCTING THE LIQUIDATION

We will realise all available assets. The assets have been valued. The liquidators have obtained a full stock take and the business assets will be sold. The debtors are factored to S.H. Lock (NZ) Limited and will continue to be collected by Lock Finance. Any surplus recovered after S.H. Lock (NZ) Limited are paid in full (under a GSA they hold) will be available for the preferential creditors and unsecured creditors following payment of preferential claims.

We will complete a thorough review of the company's books, records and affairs to:

- ensure that all assets have been properly accounted for,
- determine if there are any other avenues of recovery for creditors,
- determine if the company's officers have properly carried out their duties, and take appropriate steps where necessary.

If there are funds available for distribution to creditors we will verify creditors' claims and make a distribution. We will then complete the liquidation and request that the Registrar of Companies remove the company from the register.

7 LIABILITIES AND CREDITOR CLAIMS

7.1 Secured Creditors

S.H. Lock (NZ) Limited holds a General Security Agreement over all present and after acquired personal property. There is an expectation that this debt will be paid in full from debtor realisations.

There are many suppliers who have registered Purchase Money Security Interests against the company. Many registrations relate to the supply of insulation products. At the date of liquidation there were Nil stocks held relating to these securities. The stocks held at date of liquidation appear to be unencumbered and the proceeds thereof will therefore be available for preferential creditors.

There are also a number of securities registered over motor vehicles. Securities are held by UDC Finance Limited, BMW Finance Limited, Marac Finance Limited and Dorchester Finance Limited. Certain vehicles have more debt than the current valuation. In these cases the vehicles will be disclaimed as onerous property. Many vehicles have equity and these vehicles will be sold and funds recovered will be made available to creditors.

There are further securities held over office equipment (photocopier). The assets which are under operating leases will be assigned to the new owner at the approval of the security holder, or returned to the security holder.

The new owner will look to take assignment of vehicles or purchase the vehicles outright. Any equity in the vehicles will be recovered by the liquidators and will be available for the creditors.

Personal Property Securities Act / Reservation of Title

Should any creditor believe that they are entitled to any goods, or proceeds from realisation of goods, due to holding a perfected Purchase Money Security Interest, they should contact us immediately.

If any creditor believes that they have a Reservation of Title over goods and they have not perfected their interest, they should also contact us immediately.

7.2 Preferential Creditors

We are in the process of determining if there are any unpaid wages, holiday pay or redundancy pay owing to former employees.

We estimate that there is approximately \$25,000 owing to former employees for wages, holiday pay and redundancy pay. There are further amounts owing to contractors, however contractors are unsecured.

The Inland Revenue Department has outstanding GST, PAYE and other payroll deductions of approximately \$423,720.

7.3 Unsecured Creditors

From our review of the company's accounting records and other information we estimate that the amount due to trade creditors is approximately \$513,741. In addition to trade creditors there are further unsecured claims for loans of approximately \$225,000 and contractor claims of approximately \$22,000. A schedule of known creditors and their addresses is provided at Appendix 2, as required by Section 255(2)(c) of the Act.

A notice to creditors to prove debts or claims is included at Appendix 3. Also enclosed is a creditor's claim form for completion and return to this office by Friday, 20 December 2013. Creditors that have not made a claim by the date on the notice may be excluded from any distribution made. If you believe that you are a secured creditor please contact us and the appropriate form will be sent to you.

8 CREDITORS' MEETING / LIQUIDATION COMMITTEE

A notice of the Liquidators' decision to dispense with the meeting of creditors is provided at Appendix 4.

Pursuant to Section 314 of the Companies Act 1993, creditors are advised that at any time in the course of the liquidation the Liquidator shall, at the request in writing of any creditor or shareholder, call a meeting for the purpose of appointing a liquidation committee.

- 11. These vehicles will be sold to the purchaser of the business and the balance due to Dorchester Finance will be paid in full to release the security and provide free title.
- 12. S.H. Lock have advised that there is a further \$80K in disputed debtor balances and that there is an expectation that they will be cleared in full with a surplus available for the creditors.
- 13. An independent valuation has been gained on the values of these assets.
