#### **Receivers' First Report**

#### 1 INTRODUCTION AND APPOINTMENT

Peri Micaela Finnigan and Colin Sanderson, Accredited Insolvency Practitioners of Auckland, were appointed jointly and severally as receivers and managers of all present and after acquired personal property of Rocksay Limited ("the company") on 24 January 2019. The receivers and managers were appointed under the powers contained within in a General Security Agreement dated 1 December 2016 in favour of Margaret Mary Westlake.

#### 2 RESTRICTIONS

This report has been prepared in accordance with Section 23 of the Receiverships Act 1993 ("the Act"). In preparing this report and its appendices we have relied upon information provided to us. We have not independently verified or audited that information. Whilst all care and attention has been taken in compiling this report, we do not accept any liability whatsoever to any party as a result of the circulation, publication, reproduction or use of this report.

#### 4 EVENTS LEADING UP TO OUR APPOINTMENT

The appointment arose as a result of the company's default in meeting payments due to the secured lender. Statutory demand was made on the company and, when that expired without settlement the receivers were appointed.





#### 5 TRADING ON AND CLOSURE OF BUSINESS

The company operated two businesses, Ochre Art Supplies and the Shhh Speakeasy Bar, both in Palmerston North.

The directors had already made the decision to cease trading and close the bar prior to the receivers being appointed. The last day of trading was 24 January 2019.

In consultation with the secured creditor and the directors the decision was made to continue to trade the art supply shop whilst attempts were made to find a buyer for the business.

#### 6 PARTICULARS OF ASSETS AND LIABILITIES

Particulars of the Assets and of the Debts and Liabilities of the Company as at the date of our appointment are provided at Appendix 1.

#### 7 ASSETS COMPRISING THE PROPERTY IN RECEIVERSHIP

#### 7.1 Bar Furniture

The bar was furnished with some leaner tables, bar stools and various couches and divans. All of the furniture and leaner tables have been sold or given to charity.

#### 7.2 Art Shop Fittings and Furniture

The art shop has a number of stands and display cases for holding the various stock items. Some of these are owned by the wholesale suppliers and are not available to the receivers. There are also drawers and racks built into the premises.



#### 7.3 Art Shop Inventory

A stock take was completed on appointment of the receivers. The stock comprises paints, mediums, brushes, pens and pencils, art pads, papers, easels etc with a wholesale value of \$68,896 excluding GST.

Some stock was subject to Purchase Money Security Interests (PMSI's) and the receivers have been liaising with the PMSI holders in relation to their stock.

#### 8 PROPERTY DISPOSED OF TO DATE

#### 8.1 Bar Assets

The bar assets, consisting of some leaner tables, bar stools and arm-chairs and couches, have been sold. Realisations from the sale amounted to \$830.00. Some items were not able to be sold because of their condition. These were given to charity or disposed of.

#### 9 PROPOSALS FOR FURTHER DISPOSAL OF RECEIVERSHIP PROPERTY

We are continuing to trade the art supply shop to reduce the stock held and to retain value in the business whilst endeavours are made to find a buyer for the business as a going concern

#### 10.2 Preferential Creditors

The Inland Revenue Department has filed a preferential claim for \$2,512 due in respect of GST.



#### 10.3 Unsecured Creditors

From our review of the company's accounting records and other information we estimate that the amount due to unsecured creditors is approximately \$40,704.

The Receivers are not responsible for the administration of unsecured creditors' claims however, it appears unlikely that there will be surplus funds available for unsecured creditors.
