1 INTRODUCTION AND APPOINTMENT

Saversupermarket Manukau Limited ("the company") was placed into liquidation by special resolution of shareholder pursuant to section 241(2)(a) of the Companies Act 1993 ("the Act") on 30 April 2018 at 12:30 p.m. Peri Micaela Finnigan and Iain McLennan, Accredited Insolvency Practitioners, of Auckland, were appointed joint and several liquidators of the company.

Prior to its liquidation, the company operated as a supermarket. The lease of the premises was due for renewal on 19 April 2018 but the right of renewal was not exercised. The company was in arrears with its rent payments.

Shortly after the expiry of the lease, the landlord changed the locks at the premises. The shareholder then appointed liquidators.

5 STATEMENT OF AFFAIRS

A Statement of Affairs showing the company's estimated financial position as at the date of our appointment is provided at Appendix 1.

6 ASSETS AND PROPOSALS FOR CONDUCTING THE LIQUIDATION

The liquidators have negotiated access to the premises with the landlord. The liquidators are currently trading the business to realise the maximum value for the company's stock.

The liquidators intend to sell the company's fixed assets, including refrigeration and freezer units. If you are interested in purchasing any of the company's assets, please contact Marisa Brugeyroux of our offices on 09 306 3340 or mbrugeyroux@mvp.co.nz to discuss the same.

The liquidators will realise all available company assets and will complete a thorough review of the company's books, records and affairs to:

- ensure that all assets have been properly accounted for;
- determine whether there are any other avenues of recovery for the benefit of the company's creditors;
- determine whether the company's officers have properly carried out their duties.

The liquidators will take recovery or other actions, where appropriate.

If there are funds available for distribution to creditors, we will verify creditors' claims and make the appropriate distributions. We will then complete the liquidation and request that the Registrar of Companies remove the company from the register.

7 LIABILITIES AND CREDITOR CLAIMS

A notice to creditors to prove debts or claims is provided at Appendix 4 and a creditor's claim form is provided at Appendix 5. 7.2 Preferential Creditors

We understand that there are pre-liquidation wages owing to the company's employees, which range from four to eight weeks of unpaid wages. The value of these claims have not yet been confirmed to the liquidators.

The Inland Revenue Department has not yet provided its creditor's claim but we understand that there are amounts due in respect of unpaid GST, PAYE, and other payroll deductions.

7.3 Unsecured Creditors

The company's accounting records record outstanding creditors of \$129,862. Based on the documents received by the liquidators to the date of this report, the liquidators consider that this figure is understated.

8 CREDITORS' MEETING / LIQUIDATION COMMITTEE

A notice of the liquidators' decision to dispense with holding a meeting of creditors is provided at Appendix 3.

Any creditor or shareholder may, at any time in the course of the liquidation, request that the liquidators call a meeting pursuant to section 314 of the Companies Act 1993 for the purpose of appointing a liquidation committee. Any request for a meeting must be submitted to the liquidators in writing.
