3. EVENTS LEADING TO APPOINTMENT OF LIQUIDATORS

The director of the company has advised that the failure of the company was due to the adverse impact of financial arrangements that the company entered into, on advice, that were expected to assist with the growth of the company. Instead of assisting with company growth the arrangements meant the company lost control of its revenue collection.

The liquidators are aware of speculation that the company has previously been placed into liquidation. From the information available there does not appear to be any evidence that the company has previously been placed into liquidation, despite discussion at the end of January 2010, when the company ceased to trade, that liquidation was likely.



4. STATEMENT OF AFFAIRS

We attach a statement of the company's affairs as at the date of our appointment. This has been prepared from information provided by the officers of the company and the company management accounts, and the liquidators are not yet able to express an opinion on the validity of that information until further enquiry is made.\

There remains some doubt about the true level of accounts receivables. Unfortunately we will not be in a position to provide further clarification until our requests for detailed information from parties who have dealt with the company receivables has been met.

5. PROPOSALS FOR CONDUCTING THE LIQUIDATION

- 5.1 The liquidators will take steps to realise all the assets.
- 5.2 The liquidators will recover the books and records, and legal files of the company.
- 5.3 The liquidators will examine the books and records to ensure all assets have been properly accounted for.

The liquidators will also conduct an investigation into the affairs of the company and do all those things that would be expected of liquidators.

The liquidators have secured a large amount of company information which was made available between Wednesday 28 April 2010 and Friday 30. April 2010. The liquidators have reviewed most of the information available but have yet to gain full access to the company's accounting system.

The liquidators have commenced meeting with a number of related and third parties so as to assess areas of likely recovery however at the date of this report those discussions are not complete. The discussions to date have identified a complex situation surrounding the company's funding in the 6 months prior to the company ceasing to trade.

The liquidators have made demand for payment of the amounts due as related party advances and shareholders current accounts.

6. CREDITORS' CLAIMS

Personal Property Securities Act / Reservation of Title

Should any creditor believe that they have registered a Purchase Money Security Interest (PMSI) on the Personal Property Securities Register (PPSR) over any goods, or proceeds from realisation of goods, they should contact this office immediately.

If any creditor believes that they have a Reservation of Title over goods and they have not registered their interest on the Personal Property Securities Register, they should also contact this office immediately.

7. ESTIMATED DATE OF COMPLETION OF LIQUIDATION

It is too early yet to estimate a date of completion for this liquidation.

8. CREDITORS' MEETING

After having regard to the assets and liabilities of the company and the initial views expressed by the larger creditors, it is proposed to hold a meeting of creditors pursuant to the Companies Act 1993, for the purpose of appointing a Liquidation Committee.






