1 INTRODUCTION AND APPOINTMENT

lain McLennan and Boris van Delden, Insolvency Practitioners of Auckland, were appointed jointly and severally as liquidators of Twinaplate Limited ("the company") on 10 December 2007.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. This twenty second report should be read in conjunction with the liquidators' previous reports. This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.

No Statement of Realisations and Distributions is attached as there have been no realisations or distributions to date.

2 RESTRICTIONS

3 CONDUCT OF THE LIQUIDATION DURING THE PRECEDING SIX MONTHS

Asset Realisations

2.1 Failed Sale and Purchase Agreement

(Statement of Affairs \$205,553)

The purchaser failed to settle the sale and purchase agreement within the required timeframe. The liquidators had no option but to cancel the agreement. The fixed assets were repossessed by a secured creditor who had a specific security on the assets.

4 INVESTIGATIONS

The liquidators have commenced their investigations into the books, records and affairs of the company.





The liquidators are reviewing the outcome of a related Court hearing including the impact of the criminal findings against Mr John Henry Ede in order to decide whether or not to make claim against a number of parties, however, we have been advised that Mr John Henry Ede has been found guilty of 23 charges under the Insolvency Act, Crimes Act, and Companies Act, and has been sentenced to over 3 years in prison.

5 CREDITORS' CLAIMS

There are no creditors and any funds recovered will go to the shareholders.

6 FUNDS / LIKELY OUTCOME

Given that there are no claims from any party, no distributions are required except for any surplus funds that may become available for shareholders.

7 MATTERS DELAYING THE COMPLETION OF THE LIQUIDATION

The following matters are outstanding:

- Completion of any related party litigation
- Completion of liquidation

8 ESTIMATED DATE OF COMPLETION

Based on the information contained in this report the liquidators presently propose to complete all outstanding matters with a view to retiring as liquidators within the next two months.
